We expect these cuts to essentially be permanent so many programs may never return to full effectiveness, including many fisheries restoration and monitoring projects. However, we must realize that we work for the resource and the constituents that enjoy that resource. We have to use that focus to move forward through these lean times

Despite these trying times on several fronts, the Tidewater Chapter has managed to have a very successful year and there are some more good things on the horizon such as the upcoming chapter meeting in North Carolina. Arrangements are moving along smoothly and it is not too early to start making plans to head toward the Carolina coast for what should be another successful Tidewater meeting. Tidewater Chapter AFS EXCOM Meeting Minutes Summary August 20, 2002

The EXCOM met at the AFS National Meeting in Baltimore on August 8th, 2002. President Alan Weaver called the meeting to order. All Chapter officers were present except for the Virginia Member at Large.

Charlton Godwin, T-shirt sales coordinator (ECU Student Subunit) informed the EXCOM that t-shirt sales were brisk and that the Chapter's investment had been recouped with all remaining sales being profits.

A \$500 donation to the Estuaries Section to support an Estuarine Symposium was approved.

The Chapter's potential share of the Baltimore meeting's profits was discussed, including how to split between Maryland DNR, the Potomac Chapter, and Tidewater Chapter.

The issues surrounding dues collection were debated. The Chapter EXCOM had previously decided to go through the National AFS unlike in previous years. EXCOM members were unsure of the mechanism for funds transfer from headquarters. Roger Rulifson pointed out that questions still remained about what student subunits should do and whether

they were Chapter members in full standing. It was decided that student subunits should collect their own dues and that they would automatically become members of the Chapter, without any portion of their dues going to the Chapter. It was also decided that a membership committee should be formed of the Secretary-treasurer, Past President, and Historian, to review old membership lists and create a list of good candidates for membership renewal. It was suggested that members at large might be able to contact people in their states. Persons on the list are then to be contacted.

James Morris mentioned that a current copy of the bylaws should be produced and updated if necessary.

Eric Zlokovitz (MD Member at Large) gave a report on the Chapter's successful fundraising efforts for the Skinner Raffle. A total of \$5000 cash was donated with 50% going for international travel, 25% for student subsection travel, and 25% for the P.C. Booth fish hatchery statue at the Fish Hatchery Hall of Fame in South Dakota. There was also some left over cash to help defray travel costs for raffle winners who had to travel significant distances to collect their prizes.

Jennifer Cudney (President, ECU Student Subunit) gave a detailed report on the many activities undertaken by the Subunit on their campus and in their community. Highlights included an electrofishing workshop, a "boat rodeo" in conjunction with the Boating Safety course, planning a "Take a Kid Fishing" day with local boys and girls clubs, and a bid for Best Chapter Award from the Southern Division.

Olaf Jensen (President, Maryland Student Subunit) reported on the difficulty of trying to get a subunit organized across several geographically separated campuses. Bill Rodney proposed that some seed money should be allocated to organize a promotional event to galvanize the new subunit's membership and recruit new members. No decision was reached on this proposal.

James Morris reported that the Chapter's website was up and running and was now being hosted by the Southern Division web server. It was unclear if the expert database was functional yet. James Morris suggested that a thank you letter should be written to Fred Jansen of the Texas Chapter for significant help with the Tidewater Chapter Website.

The final item of discussion was the Chapter's upcoming Annual Meeting in Beaufort NC in mid January. James Morris presented a draft agenda. Various agenda items were discussed.

The meeting was adjourned on time.

FISHERIES NEWS FROM MARYLAND DNR:

The summer of the snakehead is finally behind us. Here are some fall news tidbits (Compiled by Darlene Pasani of MDDNR):

International Overfishing - Last week Governor Glendening of Maryland, along with several other eastern seaboard governors and environmental leaders, asked the federal government - via a petition to the Commerce Secretary - to use the threat of trade sanctions to stop overfishing of white marlin and bluefin tuna by European countries.

The Memorial Stadium Oyster Reef Sanctuary - Last week, one million baby oysters were moved into a new home: a 6 acre oyster reef three miles in the Kent County waters of the Chesapeake Bay, created with 10,000 cubic yards of crushed concrete from the demolished stadium. The man-made sanctuary is one of 26 established by DNR in an effort to restore populations devastated by disease, loss of habitat, overharvesting and pollution.

Eyes on the Bay website:

This innovative new website -- http://www.eyesonthebay.net - from DNR's tidewater assessment team, allows the public easy access to water quality information on the Chesapeake Bay and its tributaries as well as the Coastal Bays.

Virginia News

Bonnie Brown (VCU) and John Epifanio (U of Ill) recently completed a genetic assessment of blackbanded sunfish, Eneacanthus chaetodon, an endangered species in Virginia. The survey included analysis of mitochondrial DNA (mtDNA) and microsatellite genetic variation in the six known populations in Virginia, four comparative populations in New Jersey, and one in North Carolina. Both genetic characters exhibited significant geographic structuring across the range sampled. The total sample exhibited lower levels of mtDNA variation than generally observed for other centrarchids and the Virginia populations were devoid of detectable mtDNA variation, suggesting that Virginia populations likely had undergone one or more severe population bottlenecks. The data indicated a high degree of microsatellite variation in all populations, including those sampled in Virginia, suggesting that the past bottleneck(s) did not render Virginia populations genetically depauperate. The primary implications for sunfish

restoration plans in Virginia were that inbreeding should be avoided in any artificially-reared populations destined for release.

North Carolina News

The North Division of Marine Fisheries (NCDMF) released its annual report on stock status this quarter. Of greatest importance is the recovery of gag grouper, which went from an overfished species to a viable population as a result of spawning season closures and bag limit regulations. The news release from NCDMF noted that it is pleased to move another stock into the viable category, but note that they still have their work cut out on restoring southern flounder, bluefish, black sea bass, striped mullet, Atlantic croaker, white and yellow perch, American shad, blue crabs, and shellfish, all of which are still in need of recovery.

Concerning southern flounder stock viability, the NCDMF decided this quarter to increase the size limit for flounder in state waters. Beginning on October 1st, NCDMF increased the size limit of flounder from 13 inches to 14 inches with no bag limit. This management option was undertaken to comply with the interstate fishery management plan, which limits flounder harvest to 246,000 fish in 2002. Despite the increase in size limits coupled with extended ocean closures, Preston Pate (NCDMF Director) expects the number of summer flounder landed in 2002 to still surpass the 246,000 limit. Causes for the overfishing are thought to be related to a 46% increase in flounder fishing since 1997, currently there are 2 million recreational flounder fishers.

In other NCDMF news, four record breaking fish were landed in 2002 making North Carolina the place to be to catch large fish in 2002. Record breaking fish included a 39 lb. blackfin tuna (prior 34 lb. and 2.5 ounce) captured out of Oregon Inlet Fishing Center, a 2 lb 11 ounce pinfish (prior 2 lb and 4 ounces) captured at Atlantic Beach, a 105 lb. cobia (prior 103 lb.) captured at Hatteras Village, and a 61 lb. Albacore (prior 57 lb.) out of Oregon Inlet Fishing Center. NCDMF reports that the last time four records were broken in one year was in 1979.

The AFS North Carolina Chapter will be hosting the Southern Division Spring Meeting this year in Wilmington, NC. Kent Nelson (NCWRC, Committee Chair) wanted to encourage Tidewater members to submit abstracts for the meeting this year. He commented that in the past the Southern Division meeting tended to overlook marine issues and concentrated on freshwater systems. He hopes to fix that this year and looks forward to some Tidewater related presentations. The meeting is February 12- 16th, 2003. Preregistration ends January 18th and is \$69.00, afterwards it is \$89.00. Abstract submission deadlines are November 15th, and any student wishing to get free room and board (4 male and 4 females beds are available), apply with Dr. Stewart Welsh (Swelsh@wvu.edu) by January 10th, 2003. Kent noted that information packets would be sent to Southern Division members in the next few weeks.
